Executive Summary		
Executive Summary	<p>The Primary Care Commissioning Committee was held on 03 August 2017</p> <p>The following were key areas of discussion:</p> <p>Following lessons learnt from The Willows, the Committee have supported an audit template for patient notes. The audit will be a peer on peer review, focused on specific areas in order to provide value through the process. A procedure will be written to support this.</p> <p>An audit has been undertaken across the south CCGs prompted by inappropriate treatment following splenectomy. Patients identified as subject to risk of harm have been managed. There is work being carried out with secondary care in order to improve documentation, communication and management of results. Learning will be shared locally and nationally.</p> <p>NHS England has provided a specification regarding clinical peer reviews which is to be in place by September 2017. The primary care team will be communicating the process to GP practices. The CCG have submitted a self-assessment to NHS England.</p> <p>The Committee reviewed the national patient GP survey which is carried out annually. NNE had a 44% return rate. 84% of responses described their experiences with their GP practice as Good. Practices have received the survey findings and these will be considered alongside local intelligence and other sources of patient feedback.</p> <p>The Committee received a finance report and it was highlighted that the biggest overspend is currently on the Quality Outcomes Framework.</p> <p>There was considerable discussion on the risk register and mitigating actions in particular, the resource capacity in the CCG for primary care. Workforce is a CCG corporate risk and the risk in relation to primary care is in relation to delivering requirements. Workforce in primary care was discussed in detail.</p>
