	Briony Leighton provided an update on Care Home Prescribing and conformed that £31,212 had been saved through medication reviews during the PEACH study. An update was provided on the audit in relation to SIP Feeds and the ONS Guidelines that had identified that the guidelines were not being followed as stringently as possible and a it was possible for a single patient review to produce savings of £765.
