**Executive Summary**

The minutes from the meeting held on 14 March 2017 are not yet ratified and so will follow. Key highlights from the meeting are reported below.

**ASSURE**

- Paediatric Sexual Assault Referral Centre (SARC) Update:** A verbal report was presented to provide assurance about the newly commissioned Paediatric SARC service. This was presented by Dr Fiona Straw who will be leading on the service. NUH submitted the successful tender for the East Midlands and the service will 'go live' on 1<sup>st</sup> April 2018. Consultation has taken place with young people and the service will be called the East Midlands Children and Young People's Sexual Abuse Service. The service will have 2 hubs - one at NUH and one at Northamptonshire Health Care Trust. The service will see children and young people up to the age of 18 years (although 16-18 year olds will have the choice of attending the adult service) and also some adults up to the age of 24 years. All children will be supported by crisis support services and will be offered sexual health advice. It is anticipated that most children and young people will be seen between 9am and 7pm (Mon to Fri) and 9am - 5pm (Sat and Sun). There will be a 24 hour on-call service.
- Transitions update:** A presentation was provided which looked at the new transitions service between children's and adult services. It was identified that there is a new Multi-Agency transitions protocol in place and this aims to provide assurance regarding a timely, person centred approach with clear information and communication for young people. Learning has been incorporated from a recent Safeguarding Adults Review.
- Nottinghamshire Police Anti / Counter Corruption Unit:** A presentation was provided which examined the abuse of authority for sexual purposes or an improper emotional relationship by police employees/ contractors. Training has been provided across policing in order to raise awareness and identify responsibilities in respect of recognising relationships which would be perceived to have breached professional boundaries.

**ADVISE**

- Home start update:** It was confirmed that Ashfield Home start will close on 31 March 2018. A level of service will continue to be offered with the final quarter grant. Further funding options are currently being explored.
- Chairs Update and Exec Update:** These reports were presented to the Board.
- Working Together 2018:** Options papers were presented which outlined the

suggested options in relation to safeguarding arrangements and Child Death Overview Process (CDOP). Workshops were facilitated to look at **Safeguarding Arrangements** and benefits / risks were discussed. Cross authority issues were raised in relation to the interface between Greater Notts CCGs and the structures being proposed by Local Safeguarding Boards (NSCB / NCSCB). It was identified that the City arrangements are being implemented on 1<sup>st</sup> April 2018. Identified that the proposed **CDOP** alignment would meet the criteria for the recommended number of case reviews. A meeting has been arranged with current CDOP chairs and managers.

- **MASH Update:** A verbal presentation was received which supported the paper submitted. There was discussion regarding health statistics and it was agreed that future papers should be presented in a multi-agency / partnership approach as this is the model of the MASH. It was identified that the quality of referrals should be reviewed and audited at a multi-agency level and that data should reflect this rather than a single agency focus. Further information should be presented to Board after this process has been completed in order that a more balanced perspective is presented. Other partners to be involved in the process as data within the report are limited to health.
- **Ofsted Inspecting Local Authority Children’s Services (ILACs) focussed visit of care leavers:** It was identified that strengths were identified as well as areas for improvement. A key finding of this inspection was that caseloads are too high.
- **Business Plan:** It was requested that this was signed off as a working document.
- **Interim Budget:** Further dialogue required in order to agree how health contribution will be met.

**ALERT**

- Nothing to escalate to Governing Bodies or Quality Committees.
