A meeting of the safeguarding partners has taken place to consider how new arrangements should be funded. The proposal agreed, subject to ratification, is to maintain the contributions for 2019/20 at the same level as those to the NSCB the previous year. A review of the funding arrangements is then proposed to be undertaken during 2019 to enable the safeguarding partners to consider the future resourcing requirements, agree the level of funding provided by each safeguarding partner and any contributions from relevant agencies. The review will consider how the reserve should be used and the appropriate level of reserve moving forward and will also take account of the statutory guidance requirement that safeguarding partners funding of the arrangements should be 'equitable and proportionate'.
